- Tacoma Poet Laureate Christian Paige participated in an engagement with the Mayor's
  Youth Commission in early May, will be speaking at an event for SOTA, SAMI, AND IDEA
  parents in May, and will be participating in the Juneteenth BLM Mural event at Tollefson
  Plaza on June 15.
- Resources for Creatives: there were 12 attendees at the LGBTQ+ Core Competency
  workshop presented by Rainbow Center. Commissioner Brown shared her reflections on the
  workshop. The next workshop, Building Better Business Foundations Part I, will be
  presented by Spaceworks Tacoma as a hybrid workshop on June 14.
- The following dates are set for Tacoma Arts Month 2023: Proclamation on September 26, Kaleidoscope at STAR Center on October 5 with setup on October 4, Tacoma Studio Tour on October 14 and 15, and Arts at the Armory on November 11 and 12.
- Chevi Chung announced her departure from the Office of Arts & Cultural Vitality at the end
  of May.
- Council Coffee meetings have been scheduled starting May 15 and will continue through
   June. Commissioners will report out about the meetings at upcoming Commission meetings.
- Arts & Economic Prosperity Study: 896 audience surveys have been collected to date. Staff are continuing to collect organizations surveys, which will continue through May.
- Tacoma Artists Initiative Program: the first TAIP cohort meeting was held in April. Staff invited Commissioners to sign up for TAIP mid-project meetings.
