5. <u>23-0816</u> Equity in Contracting Code Update [Kacee Woods, Program Manager, Community and Economic Development]

At approximately 10:02 a.m., Kacee Woods, Program Manager, Community and Economic Development, presented Equity in Contracting program regulations including an agenda, how we got here, overview of program history, offerings and regulations, the waiver request process and request form, proposed code revisions, and next steps.

Discussion ensued throughout regarding what may be preventing businesses from applying to the program, struggles for small businesses, limited number of certified firms can prevent building capacity and work with the smaller businesses, suggestions for improvements, building capacity for larger contracts and subcontracts, suggestions for outreach and partnership with other jurisdictions, current partnerships, disparity studies, local and citywide goals, options for City staff to delegate authority and have direct negotiations for contracts, additional discussion at study session, how the certification process works, companies that are not required to be certified, support staff, and upcoming expiration of the current code.
