SUMMARY:

The Information Technology Department recommends a contract be awarded to Motorola Solutions Inc., a corporation in the state of Delaware, in the amount of \$5,461,280.00, plus applicable sales tax, for a 10 year System and Security Upgrade contract.

STRATEGIC POLICY PRIORITY:

Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

The contract assures outstanding stewardship of the natural and built environment and promotes an efficient, effective government which is fiscally sustainable by continuing to refresh and update the City's public safety radio system.

BACKGROUND:

The City's 800 MHz radio system has provided radio communications for the City's General Government departments as well as to law enforcement, fire and other first responder agencies throughout the Tacoma metropolitan area since 2003. A major project to upgrade from analog "SmartZone" to digital "AstroTac P25" began in mid-2013, including new digital radios for all users. The digital system was ready for use by late 2014.

ISSUE: Unlike the City's analog system, the \$10 million digital system is a network of components that include hardware, software and application programs. With a brief 5 to 7 year product lifecycle for today's computer technology, approximately 40% of components are projected to reach both "end of life" and "end of support" between 2016 and 2020.

Within these lifecycles, Motorola releases and sells annual product enhancements to improve performance and reliability. Some enhancements are released frequently (monthly, quarterly or semiannually) while others are released less frequently (annually or bi-annually). Regardless of how often improvements are released, approximately 40% of the components will need replacement between 2016 and 2020. The Motorola System Upgrade and Security Service Agreement will provide one major upgrade each biennium.

ALTERNATIVES: The City's alternative is to individually upgrade components as they reach end of life and support. Although possible, this alternative is highly labor intensive for City staff and approximately \$500,000 more expensive over a 10 year time period.



COMPETITIVE SOLICITATION: This is a sole source contract.

COMPETITIVE ANALYSIS: Motorola is the sole source manufacturer of approximately 90% of the hardware and software of the AstroTac P25 system. Motorola purchases the remaining components from third parties such as Cisco, Hewlett-Packard and Microsoft and is the sole source provider of all third party modifications required to function properly with the AstroTac P25 system. Therefore, the hardware/software included in this agreement represents unique products and services only provided by Motorola.

The contract cost effectively addresses all issues associated with maintaining and improving the performance and operation of the City's radio system by enhancing, upgrading or replacing products as necessary. The contracted schedules for work will save approximately \$500,000 over 10 years while reducing time required by City staff to research and deploy end of life and support replacements. The recommended effective date of this contract is January 1, 2016.

CONTRACT HISTORY: This is a new contract.

SUSTAINABILITY: Motorola's Green Building Strategy delivers targeted actions to improve the environmental performance of specific products and facilities. Motorola regularly conduct EHS audits at its sites to assess compliance with EHS policy, management, system and legal requirements. Motorola's global energy team coordinates energy management activities across all Motorola Solutions business units.

SBE/LEAP COMPLIANCE: Not applicable.

RECOMMENDATION:

The Information Technology Department recommends a contract be awarded to Motorola Solutions Inc., a corporation in the state of Delaware, in the amount of \$5,461,280.00, plus applicable sales tax, for a 10 year System and Security Upgrade contract.

FISCAL IMPACT: The fiscal impact of the first year of this recommended contract equals \$520,600.00, plus applicable sales tax. Funds are appropriated in the 2015-2016 biennial budget within the Radio Communication Revolving Fund 5540.
