- 4. Summer Late Nights: Summer Late Nights began on Monday, June 23, 2025, at 10 locations across Tacoma. Programming will run through Friday, August 29, 2025. The ten-week drop-in program offers safe spaces for middle and high school students to hang out and receive dinner every weeknight. Local providers are contracted by the Tacoma Parks Foundation to offer a variety of engaging activities each week including open gym, art, and music activities. Over 1,500 young people from Tacoma are expected to participate with over 15,000 drop-in visits anticipated. - 6. <u>Encampment Outreach:</u> For the week of August 4 8, 2025, the HEAL team visited 13 locations. This resulted in 20 (9 new, and 11 repeat) individuals contacted and referred to community services; 2 individuals were placed in shelter. 



BACKGROUND:

Per Section 2.8 of the City Charter as amended by a vote of the people during the general election on November 5, 2024, entitled Procedure of the Council, the City Council shall hold at least 70 regular meetings each calendar year which includes Council meetings and study sessions.

At the December 10, 2024, study session, the City Council discussed the following dates as proposed options for the cancelled City Council meetings and study sessions in 2025. The proposed resolution would amend the approved cancellations as shown below:

- Tuesday, January 21
- Tuesday, February 18
- Tuesday, March 11
- Tuesday, April 8 (study session only)
- Tuesday, May 27
- Tuesday, September 2
- Tuesday, September 23
- Tuesday, November 4
- Wednesday, November 12
- Tuesday, November 25
- Tuesday, December 23
- Tuesday, December 30

Most of the dates selected fall one day before or after a legal holiday. Per Rule 1A of the Rules of the Procedure of the Council of the City of Tacoma, entitled Regular Meetings, if a legal holiday is on a Tuesday, the regular meeting shall be held on the next business day. In 2025, the City of Tacoma observes Veterans' Day on Tuesday, November 11, 2025, and would hold the regular meetings of that week on Wednesday, November 12, 2025.

To remain responsive to community needs and ensure Council participation in significant local events, adjustments to the Council meeting schedule have been made. These changes allow Council Members to be present and engaged in key community activities, while also maintaining an adequate number of business meetings, particularly through holiday months to ensure timely action on city matters.



ALTERNATIVES:

The City Council could determine alternative dates to cancel.

STAFF/SPONSOR RECOMMENDATION:

Staff recommends that these City Council meetings and study sessions be cancelled in 2025 and requests City Council consideration at the August 19 Council meeting.
