Animal Control - Animal Retail

[Captain Shawn Stringer, Tacoma Police Department]

At approximately 4:37 p.m., Chair Woodards stated that after public testimony was heard at a City Council meeting regarding pet retail in the City, the Committee wanted to have an information briefing on how many operations are in the City, and current regulations. Captain Shawn Stringer, Police, stated currently there is only one commercial pet store in Tacoma, Pets and Pals Supply, and any other stores affiliated with pet sales work directly with the Humane Society.

Captain Stringer defined the term animal as dogs and cats, and then reviewed code language, pet transfers between individuals, and online sales. Discussion ensued regarding defining animals, bans on the sale of pets in other municipalities, the number of pets sold at Pets and Pals Supply, incident calls to the site, and soft bill birds.

Council Member Lonergan requested staff review the AKC breeding policies.
