Community Vitality and Safety Committee

Council Member Blocker, Chair of the Economic Development Committee, reported at the November 8, 2022, meeting, the Committee heard from a panel of local entrepreneurs to highlight updates and news from Tacoma's technology-related startup ecosystem; and on November 22 and 29, 2022, the Committee conducted interviews for the Tacoma Arts Commission. He concluded by stating the next meeting will be in a hybrid format on December 13, 2022, the Committee will receive presentations on the Maritime Blue Incubator and the Port of Tacoma.
