Prologis Park Tacoma Update [Martha Anderson, Assistant Director, Community and Economic Development]

Council Member McCarthy arrived here, at 10:05 a.m.

At approximately 10:05 a.m., Martha Anderson, Community and Economic Development (CED), provided brief opening remarks and introduced Dan Letter, MD Capital Deployment. Mr. Letter discussed background information, sustainability awards and recognitions, and introduced Rick Kolpa and Ken Sun, MD Capital Deployment. Mr. Sun reviewed Prologis Park Tacoma, site development and road improvements. Mr. Kolpa discussed marketing and leasing. Mr. Sun continued with the sustainability attributes of Prologis LEED certified buildings.

Discussion ensued regarding boundary lines, additional plans scheduled for site development, traffic studies conducted, additional Prologis locations, industrial and retail real estate, availability for growth, continued Port of Tacoma growth, Prologis and Burlington Northern Santa Fe railroad discussions, and job creation.

City of Tacoma Business Survey Results [Martha Anderson, Assistant Director, Community and Economic Development]

At approximately 10:38 a.m., Martha Anderson, CED, provided brief opening remarks and introduced Amy Thomas, City Manager's Office, and Stewart Elway, Elway Research, Inc. Ms. Thomas provided an overview of the survey conducted and background information for Elway Research, Inc. Mr. Elway discussed the purpose of the survey, methods and provided a sample profile. Mr. Elway then reviewed the business climate, including a grading scale, challenges, 2016 property tax rate, 2016 sales tax rate, impacts on businesses, performance, rate of satisfaction in contact with City government, overall satisfaction rate, internet services, and reliability.

Discussion ensued throughout regarding the grading process, population finances, development in the workforce, tax rates, parking impacts rating, overall workforce quality, continued future business surveys, similar surveys available, additional possible questions, business types, tax and licenses, gross receipts, and total responses from businesses.

Downtown Commercial Office Incentives [Elly Walkowiak, Business Development Manager, Community and Economic Development]

At approximately 11:17 a.m., Elly Walkowiak, CED, provided brief opening remarks on downtown commercial office incentives and introduced Randy Lewis, Government Relations Office. Ms. Walkowiak discussed urban population growth, City populations, urban county employment growth, urban county median wage comparison, employment disparity, challenges for urban centers outside of King County, return on investment in Tacoma, encouraging secondary markets, successful development, employment, and population, proposed state legislation principles and parameters, and concluded by discussing next steps and state benefits. Mr. Lewis discussed changes in government and state legislation.

Discussion ensued regarding class A, B and C office space, property tax, property tax exemptions, market demand, strategies, additional tools, and local business and occupation taxes.
