COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Deputy Mayor Walker, Chair of the Infrastructure, Planning, and Sustainability (IPS) Committee, reported at the October 11, 2023, meeting, the Committee received a combined report out from four of the five committees, boards, and commissions, assigned to the IPS Committee, each reported a brief overview of their activities and future goals for the coming year; on October 25, 2023, the Committee received updates on the Schuster Parkway Trail project design and the Home in Tacoma Phase 2 project; on November 8, 2023, the Committee reviewed applicants for the Sustainable Tacoma Commission youth member position, and received a presentation from the Landmarks Preservation Commission regarding further review of Gault Middle School, a Vision Zero update, and an Active Transportation program update. She concluded by stating the next meeting will be held in a hybrid format on December 13, 2023, at 4:30 p.m., and will include interviews for the Landmarks Preservation Commission and the Planning Commission's annual report.


