1. <u>23-1083</u> Tacoma Arts Commission Interviews [Nicole Emery, City Clerk]

At approximately 10:06 a.m., Susan Haigh, Deputy City Clerk and RIM Administrator, informed the Committee they would be interviewing seven applicants for the Tacoma Arts Commission and reviewing three written responses and there are currently six positions available on the Commission.

The Committee interviewed Daniel Arias-Gomez, Connie Behe, Katie Dean, Hannah-Clarke Gilmore, Marena Shear, Jes Takla, and Wind Dell Woods. The Committee further reviewed written responses from Jasmine Brown and Jeannette Sanchez, who were seeking reappointment, and Amy Van Mechelen, who was unable to attend the interviews.
