At approximately 10:01 a.m., Nicole Emery, City Clerk, reviewed the adopted Resolution No. 41491 which transmitted six proposed Charter amendments to the November 5, 2024, Special Municipal Election ballot. She explained that on July 30, 2024, the Council will consider a resolution appointing members to the “For” and “Against” Committees based on the recommendations from this Committee. She continued with the process of how the City Clerk's Office advertised for people that would prepare statements for the Voters' Pamphlet and deadline for the submittal process.

Discussion ensued regarding process for when there are no volunteers for a "For" or "Against" committee and background and clarification of each proposed Charter amendment.

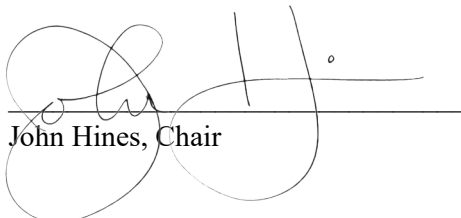

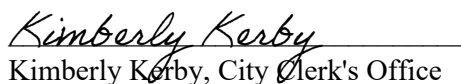
