SUBJECT:	Resolution authorizing an agreement with Pierce Transit for part of the City's Commute Trip Reduction Program– February 9, 2016
DATE:	January 22, 2016

### **SUMMARY:**

A resolution authorizing execution of an agreement between the City of Tacoma and Pierce Transit, in the net amount of \$361,006.18 for the purchase of the ORCA (One Regional Card for All) Business Cards that will be part of the City's Commute Trip Reduction Program for 2016.

# **BACKGROUND:**

Beginning in 1996, as part of the City of Tacoma's Commute Trip Reduction (CTR) Program, the City provided bus passes/van pool subsidies for its employees. In 2009, the City transitioned from providing these subsidies to the ORCA (One Regional Card for All) Business Card for the CTR Program.

In 2010, there were approximately 800 employees who used an ORCA Card for their commute to/from work. In 2011, there were approximately 985 transit program users; in 2012, approximately 935 transit program users; in 2013, approximately 1059 employee transit program users, in 2014 approximately 1127 employee transit program users and in 2015, approximately 1177 transit program users. The current number of transit and van pool riders represents approximately thirty percent (33%) of the City of Tacoma's workforce.

The ORCA Business Card provides employees' access to Pierce, Metro, Kitsap, Everett Community, and Sound Transit Systems including Sound Transit Link Light Rail, Seattle Streetcar and the Sounder. The agreement also provides vanpool and vanshare services from these systems.

The 2016 agreement is in the amount of \$361,006.18, which includes both a \$390,761.74 annual program fee for ORCA Transit and Vanpool services (paid from the General Fund), and a credit of (\$29,755.56) for 100 cards as an offset for Pierce Transit rent (charged as revenue directly to TPU). The cost decrease of \$23,970.02 over 2015 is due to overall lower transit and vanpool usage by employees. NOTE: Approximately 67% of the \$390,761.74 charged to General Fund is assessed out to other funds, including Tacoma Public Utilities (TPU).

Human Resources staff will continue the oversight of the CTR transit pass program. Each employee receiving an ORCA card will be required to sign a Terms of Agreement outlining use expectations and requirements.

# **ISSUE:**

Authorization to execute the agreement is required to continue to provide services as part of the City's Commute Trip Reduction Program.

# **RECOMMENDATION:**

It is recommended that the City Council take the necessary action to approve the legislation.

### FISCAL IMPACT:

\$361,006.18 (net impact to the City as a whole, with total expenditures in the General Fund of \$390,761.74 and of that amount \$29,755.56 being refunded to Tacoma Power as revenues in the form of a rebate.
