## **ORDINANCE NO. 28201**

AN ORDINANCE relating to the Compensation Plan; amending Section 1.12.355 of the Tacoma Municipal Code and declaring the effective dates thereof to implement rates of pay for classifications represented by the Tacoma Police Union, Local 6, I.U.P.A.; Tacoma Police Management Association, Local 26; and Professional Public Safety Managers Association.

WHEREAS the collective bargaining agreement with Tacoma Police Union, Local 6, I.U.P.A., was approved pursuant to Resolution No. 38418, adopted on January 24, 2012, and represents approximately 374 budgeted, full-time equivalent positions, and

WHEREAS the agreement provides for a market-based wage increase in order to maintain ranking among the comparables for 2013 and 2014, and

WHEREAS the City and Tacoma Police Union, Local 6, have reached a settlement regarding wages for 2013 and 2014, as follows: effective January 1, 2013, base wages for Local 6 classifications will be increased by 2.5 percent; and effective January 1, 2014, base wages will increase by 1.2 percent, and

WHEREAS the 2012-2014 collective bargaining agreement with the Tacoma Police Management Association, Local 26, was approved pursuant to Resolution No. 38532, adopted on August 28, 2012, and represents approximately 19 budgeted, full-time equivalent positions, and

WHEREAS the agreement provides language for 2013 and 2014 wages to be determined by an indexing/parity process between the classifications they supervise in Tacoma Police Union, Local 6, and

WHEREAS wage increases of 2.5 percent, effective January 1, 2013, and 1.2 percent, effective January 1, 2014, are necessary to maintain the



indexing/parity differentials provided for in the collective bargaining agreement, and

WHEREAS the 2012-2014 collective bargaining agreement with the Professional Public Safety Managers Association was approved pursuant to Resolution No. 38388, adopted September 27, 2011, and represents approximately 10 budgeted, full-time equivalent positions, and

WHEREAS the agreement provides language for 2013 and 2014 wages to be determined by an indexing/parity process between the classifications they supervise in the Tacoma Police Union, Local 26, and Tacoma Firefighters Union, Local 31, and

WHEREAS wage increases of 2.5 percent, effective January 1, 2013, and 1.2 percent, effective January 1, 2014, are necessary to maintain the indexing/parity differentials provided for in the collective bargaining agreement, and

WHEREAS City Council authorization is required to implement rates of pay and compensation within the collective bargaining agreements that have been negotiated with the unions on behalf of their represented employees; Now, Therefore,

## BE IT ORDAINED BY THE CITY OF TACOMA:

Section 1. That Section 1.12.355 of the Tacoma Municipal Code is hereby amended, effective retroactive to January 1, 2013, to read as follows:
