2. 15-0169

Transportation Master Plan

[Josh Diekmann, Assistant Division Manager, Public Works]

At approximately 4:30 p.m., Josh Diekmann, Public Works, reviewed the Transportation Master Plan scope of work, including public engagement, existing conditions, goals, modal networks, performance measures, financial plan, and the Growth Management Act and concurrency. He then reviewed the schedule for adoption, outreach, next steps, and code review.

Dr. Jane Moore, Transportation Commission, reviewed the Transportation Commission's review of the plan. Discussion ensued regarding performance measures, the vision statement, aligning with plans to improve road conditions, and potential public feedback regarding the plan. Chair Mello requested staff provide the entire Council with a copy of the draft plan. Deputy Mayor Boe requested the finalized meeting schedule for public meetings.

3. 15-0170 Introduction of Rates for Commercial Yard and Food Collection [Gary Kato, Division Manager, Environmental Services]

At approximately 4:53 p.m., Gary Kato, Environmental Services, provided background information on the Commercial Yard and Food Waste Pilot Program, including the collection process and schedule, equipment used, rate development, and implementation. He then reviewed a commercial food waste market analysis, proposed commercial rates, rate comparisons with other jurisdictions, and service options.

Council Member Walker arrived here, at 5:03 p.m.

Mr. Kato continued to review service options, including food waste only, yard waste with food, and large commercial. He concluded by reviewing the implementation timeline and code language. Discussion ensued regarding multi-family development participation, commercial rate target participants, and implementation.
