NOTICE OF APPEAL OF HEARING
EXAMINER'S FINDINGS OF FACT,
CONCLUSIONS OF LAW, AND
RECOMMENDATION

Appellant, the YWCA PIERCE COUNTY ("YWCA"), a Washington non-profit corporation, hereby appeals the Findings of Fact, Conclusions of Law, and Recommendation of the Hearing Examiner issued in this matter on May 26, 2017 ("Recommendation"), pursuant to Tacoma Municipal Code ("TMC") Chapter 1.70.

I. FACTS AND UNDERLYING RECOMMENDATION

On April 18, 2006, the Tacoma City Council ("Council") adopted Substitute Ordinance No. 27475, which approved formation of Local Improvement District No. 8645 (the "LID"). (**Recommendation at 2, FOF 1**). Actual construction activity of the LID was completed in 2011, but final contractor payments were not finalized until late 2012. (*Id.* at 4, FOF 4).

Over five years after the completion of construction, the Final Assessment Roll for the LID was filed in the Office of the City Clerk, assessing amounts against each property benefited by the LID for the payment of the costs and expenses of the LID improvements. (*Id.*, FOF 5). The final total assessed to property owners within the LID was \$7,644,443.17, far higher than the original estimate of \$3,915,000.00. (*Id.* at 5, FOF 8). The YWCA, a non-profit agency that owns three commercial parcels and two vacant parcels within the LID,¹ was assessed a total of \$427,137.00. (*See Exhibit A, LID Assessment on YWCA*). A public hearing on the Final

1 Assessment Roll was conducted by the Hearing Examiner on March 29 and March 30, 2017.
2 (*Id.* at 4, FOF 6).

3 The Final Assessment (“Assessment”) is based on a Special Benefits Study prepared by
4 Valbridge Property Advisors, Inc. (“Valbridge Study”). (*Id.* at 5, FOF 8). The Valbridge
5 Study’s methodology did not involve an individualized appraisal of each of the over 400
6 properties, but rather determined an initial value for the type or category of property before the
7 LID improvements were constructed. (*Id.* at 6, FOF 10). An additive factor was then calculated
8 for each type or category of property based on a value analysis, and the figure was added to the
9 original value to determine the value post-improvement. (*Id.*). Relevant to the issues in this
10 appeal, the Valbridge Study calculated a four percent additive factor for office, retail, and
11 commercial properties largely based on vacancy rates and walkability—rather than more
12 standard recognized appraisal techniques such as income analysis and sales comparisons. (*Id.* at
13 15, FOF 30).

14 Property owner William Riley provided a competing review of the assessments produced
15 by Barbara Montro (“Montro Review”). (*Id.* at 14, FOF 28). The Montro Review critiqued the
16 Valbridge Study’s reliance on vacancy rates and walkability, rather than income analysis and
17 sales comparisons, and concluded that the four percent additive factor for office, retail, and
18 commercial properties was “erroneous and unsupported by proper data and analysis.” (*Id.* at 16,
19 FOF 32–34).

20 After review of the two competing analyses, the Hearing Examiner found that while the
21 “Valbridge Study has some rationale to support an increase in values...the level of detail and
22 justification using recognized appraisal techniques for quantifying the amount of increase is
23 weak.” (*Id.* at 17, FOF 35). As a result, the Hearing Examiner concluded that “there is
24 evidence that...the methodology used to substantiate the assessments was incomplete or
25 erroneously applied.” (*Id.* at 31, Conclusion 6). The Hearing Examiner went on to conclude
26 that “Office/Retail/Commercial property is not recommended for confirmation...[and that]

1 further appraisal analysis is needed to support the 4 percent benefit suggested for this type of
2 property.” (*Id.* at 32, Conclusion 6(c)). Specifically, the Hearing Examiner determined that the
3 “evidence was insufficient to support the specific 4 percent adjustment applied in the Valbridge
4 Study.” (*Id.*).

5 Despite these findings and conclusions, the Hearing Examiner recommended The City
6 Council approve the Assessment in its entirety “after implementation of the modifications”
7 suggested in the Recommendation. (*Id.* at 33, Reco.). As to the four percent adjustment applied
8 to office, retail, and commercial properties, the Recommendation suggested that the Council
9 “may wish to consider requesting further appraisal analysis...to more fully document the basis
10 for selecting a 4 percent increase” prior to approval of the Assessment. (*Id.* at 32, Conclusion
11 6(c)).

12 II. RIGHT TO APPEAL

13 The YWCA has the right to appeal the Recommendation pursuant to TMC 1.70.010 as a
14 result of the following:

- 15 1. The YWCA owns commercial property in the LID that is the subject of the Assessment
16 and Recommendation;
- 17 2. The YWCA was assessed a total of \$427,137.00 in the Assessment;
- 18 3. The YWCA was a party to the Hearing Examiner’s Decision;
- 19 4. A favorable decision will substantially redress the harm to the YWCA from the erroneous
20 four percent adjustment used to calculate the assessment on the YWCA’s commercial
21 properties.

22 III. STANDARD OF REVIEW AND ASSIGNMENTS OF ERROR

23 Under TMC 1.70.010.C, the City Council may grant relief from the recommendation of
24 the Hearing Examiner when an appellant establishes any of the following:

- 25 (a) The Hearing Examiner is engaged in unlawful procedure or
26 failed to follow a prescribed process, unless the error was

1 harmless;

2 (b) The recommendation is an erroneous interpretation of the
3 law;

4 (c) The recommendation is not supported by evidence that is
5 substantial when viewed in light of the whole record before the
6 Council; and

7 (d) The recommendation is a clearly erroneous application of
8 the law to the facts.

9 TMC 1.70.010.C.

10 The YWCA assigns error to the Hearing Examiner's Findings of Fact, Conclusions of
11 Law, and Recommendation in the following respects:

12 1. The Hearing Examiner erred in FOF 35 by determining that the "Valbridge Study has
13 some rationale to support an increase in values" for office, retail, and commercial
14 properties, and that the "level of detail and justification using recognized appraisal
15 techniques for quantifying the amount of increase is weak." Recommendation, FOF 35.
16 In fact, there is no evidentiary support for the four percent adjustment assigned to office,
17 retail, and commercial properties. The Hearing Examiner's determination that "some"
18 support existed for the four percent adjustment is not supported by substantial evidence.
19 TMC 1.70.010C(c).

20 2. The Hearing Examiner erred in Conclusion 6 by recommending approval of the
21 Assessment despite the City of Tacoma's failure to meet its burden of proof under *Hasit*
22 *LLC v. City of Edgewood*, 179 Wn. App. 917, 936-37, 320 P.3d 163 (2014) to establish
23 that the four percent adjustment applied to office, retail, and commercial properties was
24 sufficiently supported by evidence in the record. The proper remedy for the City of
25 Tacoma's failure to meet its burden of proof under *Hasit* is to decline confirmation of the
26 four percent adjustment, and order a new assessment study open to public participation
and comment. *See id.* As a result, the Hearing Examiner's decision to recommend
approval subject to modifications is an erroneous interpretation of the law, and/or is not
supported by substantial evidence, and/or is a clearly erroneous application of the law to

1 the facts. TMC 1.70.010.C(b)-(d).

- 2 3. The Hearing Examiner erred in Conclusion 6(c) to the extent that the Hearing Examiner's
3 recommendation to approve the Assessment after the Council reviews "additional
4 appraisal analysis" suggests that any additional appraisal analysis will not be open to
5 public review, comment, and challenge. Failure to open additional appraisal analysis to
6 public participation strips interested parties of the fundamental right to due process. *See*
7 *Hasit*, 179 Wn. App. 917, 952, 320 P.3d 163 (2014). The Hearing Examiner's
8 recommendation that the Council can review additional appraisal analysis without public
9 participation is an erroneous interpretation of the law. TMC 1.70.010.C(b).

10 As a result, the City Council should grant the YWCA relief from the Recommendation of
11 the Hearing Examiner under TMC 1.70.010.C.

12 **IV. REQUEST FOR RELIEF**

13 For all of the above reasons, the YWCA respectfully requests that the City Council deny
14 approval of the Assessment as it pertains to office, retail, and commercial properties. The
15 YWCA further requests that the City Council order a new assessment study—open to public
16 participation, comment, and challenge—in order to determine the appropriate special benefit
17 conferred to office, retail, and commercial properties within the LID.


