Briefing Items

2. <u>15-0983</u> Short Term Rentals

[Brian Boudet, Planning and Development Services; Danielle Larson, Finance Department]

At approximately 4:35 p.m., Brian Boudet, Planning and Development Services (PDS), provided background information on the current rental market and home sharing in the City, and introduced Danielle Larson, Finance. Mr. Boudet reviewed current City regulations on individual room lodging rentals, potential concerns and benefits, general trends regarding short term rentals, other jurisdiction's regulations, and the current opportunity to add

standards to the City's regulations. Discussion ensued regarding short term rentals currently within City limits, potential problems for neighbors surrounding short term rentals, requiring permanent residency within short term rentals, application process to stay at an Airbnb, accessibility requirements, enforcing license requirements, the ability to experience neighborhoods, Internal Revenue Service's definition of a rental property, and license requirements and code standards.

3. <u>15-0984</u> Proposed Narrowmoor Addition Conservation District [Reuben McKnight, Planning and Development Services]

At approximately 5:08 p.m., Rueben McKnight, PDS, provided an overview of the West Slope Conservation District, including the proposed Narrowmoor Addition Conservation District, preserving housing characteristics, issues within the district, proposed legislation to amend the current code, public review process, support and feedback, key comments, emerging issues regarding lot width, and next steps. Discussion ensued regarding code changes within a specific district, maintaining through lots while subdivided existing lots, covenant regulations, defining a story or level of a house, creating density, and affordable housing.

Public comment was heard from Dean Wilson and Mike Fleming, West Slope Neighborhood Coalition.

Discussion continued regarding streetscape and location standards, protected views, and maintaining neighborhood characteristics. Deputy Mayor Boe requested staff provide site examples.
