1. <u>15-1117</u> Tacoma Public Library Updates

At approximately 12:05 p.m., Susan Odencrantz, Director, Tacoma Public Library (TPL), provided background information regarding the Pathway Program, and introduced Sarah Holloway, TPL, and Merilee Tanbara, Tacoma Public Schools (TPS). Ms. Holloway and Ms. Tanbara provided information relative to the Pathway Program.

Ms. Odencrantz then introduced Beverly Choltco-Devlin, TPL, and Jeannette Twitty, House of Matthew. Ms. Choltco-Devlin and Ms. Twitty provided an overview of the Homeward Bound Program.

Ms. Odencrantz continued the presentation by introducing Kelda Vath and Tracie Goodrick, TPL. Ms. Vath and Ms. Goodrick reviewed upcoming changes to the Tacoma Public Library website, www.tacomalibrary.org.

Ms. Odencrantz introduced Christine Bassett, TPL. Ms. Bassett provided a brief background relative to Radio-Frequency Identification (RFID) technology and reviewed the RFID library system, including completed phase one, and upcoming phases two and three.

Discussion ensued throughout the presentation regarding archives in the Northwest Room, the percentage of libraries that use RFID technology, budget, support of using RFID technology, number of citizens in the Homeward Bound Program, expanding the Homeward Bound Program, and increased utilization of libraries.
