1. 14-0065 Legislative Update

Mayor Strickland announced the first study session topic is a legislative update from Randy Lewis, Government Relations Officer. Mr. Lewis reviewed upcoming key dates and provided a summary of the City's legislative agenda. He then provided session updates for agenda issues, including liens, waste oil, speed cameras, foreclosures, yacht use permits, sex offender residences, marijuana, and transportation. Discussion ensued regarding the speed camera pilot; marijuana issues, including revenue sharing, additional data needed, and the McCLeary decision; and potential transportation initiatives in King County.

Agenda Review

City Manager T.C. Broadnax stated two additional resolutions may be considered tonight, Resolution Nos. 38838 and 38839, expressing support for and urging Tacoma voters to vote "Approved" on Tacoma Public School District No. 10 Proposition Nos. 1 and 2 on the February 11, 2014 Special Election ballot. He then stated there will be three proclamations proclaiming February 15, 2014, as Chancellor Debra Friedman Day; February 2 – 8, 2014, as Toastmasters International Week; and February 7 – 14, 2014, as Congenital Heart Defect Awareness Week. Mr. Broadnax noted there will be a recognition of Fab-5 for their completion of the Hilltop Business District Flower Pot Painting Project.
