### Briefing Items

[Debbie Bingham, Program Manager, Community and Economic Development]

At approximately 10:09 a.m., Jeff Robinson, Director, Community and Economic Development (CED), provided opening remarks. Debbie Bingham, Program Manager, CED, presented the Economic Development Strategic Plan update, and outlined the eight initiatives in the plan, including to strengthen the local economy, noting focus on core companies and adding smaller companies; develop authentic and emerging industries, noting increasing the number of loans to be given out; promote downtown as the center of commerce for the South Sound; create a trained, future-ready workforce, noting funding for programs, workforce programs with partners and a focus on single parents; and build increasingly vibrant neighborhoods, noting 2020 pandemic grants, window replacement, and business innovation funds; support employment-generating activities and office industrial product, noting the Tideflats Subarea Plan will be going through a follow up to see what will be and the green economy plan has been finished, staff have been hired and the recruitment plan is for 2024; implement premier customer

service; and marketing noting the theme "Choose Tacoma to Live, Work, and Explore", sponsoring events and magazines, and budget limits.

Council Member Scott arrived here, at 10:19 a.m.

Discussion ensued regarding campaigning; funding with Greater Seattle Partners; family wage tax; Green Jobs tax credits; support for the CED department; the Rook Apartment project for downtown; community involvement with Business Improvement Areas (BIA) and differences in the BIAs; problem locations and success rates; retail advocacy; development fees; workforce standards; marketing; budget increase; high wage jobs needed in Tacoma; company growth; consolidated action items for the 2025 strategic plan; geopolitics; home-based micro businesses; high interest sites for purchasing and developing; University of Washington Tacoma Strategic Plan for the area, how the City is involved, and student housing; and ways to bring an additional grocery store to the downtown area.
