At approximately 4:30 p.m., Chair Ushka provided opening remarks regarding the Tacoma Area Commission on Disabilities (TACOD) interviews, including that tonight is a continuation of interviews from the previous meeting, where Tony Hester, Billie Periman, and Cheri Coleman were recommended for appointment. Nicole Emery, City Clerk, informed the Committee that they would be interviewing one additional applicant, Hayley Edick, for the TACOD.

The Committee interviewed Hayley Edick.

Discussion ensued regarding the remaining two vacancies, and the qualifications of applicants.

MOTION: Council Member Rumbaugh moved to recommend the appointment of Hayley Edick to the Tacoma Area Commission on Disabilities to serve a three-year term, retroactive to September 1, 2023, to expire August 31, 2026.

2. [23-0888](#) Mental Health and Substance Use Disorder Sales Tax - Mental Health Assessment [Vicky McLaurin, Interim Assistant Director, Neighborhood and Community Services; Dawn Couch, Senior Project Manager, Berk Consulting]

At approximately 4:47 p.m., Vicky McLaurin, Interim Assistant Director, Neighborhood and Community Services, and Dawn Couch, Senior Project Manager, BERK Consulting, presented on the Mental Health and Substance Use Disorder (MHSUD) Sales Tax and mental health assessment with an overview; mental health and chemical dependency sales tax with a breakdown of what the tax was authorized to be used for; Tacoma’s MHSUD sales tax; funding timeline from 2005 through 2022; current funding guided by Council goals; project purpose, noting key questions, overview of how funds can be used, how funded programs support the community goals and priorities, outcomes of direct funding, and how the City can optimize the funding to achieve priorities for the project approach; and a timeline.

Council Member Daniels arrived here, at 5:05 p.m.

Discussion ensued regarding housing needs of the population based on mental health crisis, recommendations to fill the gap of funds for individuals released from prison that need assistance, the use of the mental health treatment

program and how the program and funds can be used to address the opioid, fentanyl, and mental health crises, funding gaps analysts, and outreach to see how funds between the City and Pierce County can be pooled together to provide resources.
