## **Briefing Items**

**1. 23-0766** 

Minimum Building and Structures Code Compliance Update [DeJa Irving, Code Inspector Supervisor, Neighborhood and Community Services]

At approximately 4:38 p.m., DeJa Irving, Code Compliance Supervisor, Neighborhood and Community Services, presented on the Minimum Building and Structures code compliance update, including an overview; substandard buildings; derelict buildings; unfit or dangerous buildings; building case types open and closed 2022; building cases on the top 10 list; and compliance options.

Discussion ensued regarding how equity education is provided, resources, assistance, connections to other departments, realistic compliance timeline and an expectation for all violations. Voluntary compliance for owners obtaining permits to do repairs, demolitions, sales, and building new structures; and a plan to meet with another jurisdiction to learn how to present a code

permission for the structures.

2. 23-0767 Opioid Settlement Update[Jacques Colon, Chief Strategy Officer, Office of Strategy]

At approximately 5:01 p.m., Jacques Colon, Chief Strategy Officer, Office of Strategy, presented on the opioid settlement strategy, including an agenda; opioid settlement background; opioid abatement council; spending options for jurisdictions; settlement funding options, noting treatment facilities with long term beds, methadone and suboxone treatment clinics, Pierce County drug court through drug programs; and settlement funding options, noting regional and local approaches, categories, investments, and costs.

Discussion ensued regarding the investment of narcan needs along with resources to support staff and resources to assist inpatient and outpatient needs; local approach for external funding, consulting with external outreach programs to see how funds can be utilized; the homeless population and drug dependent individuals being assisted through the court system; guidelines with limited funds, a suggestion to research matching dollars with the state and county to see if there are further funds available.
