COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Neighborhoods and Housing Committee

Council Member Walker, Chair of the Neighborhoods and Housing Committee, stated on February 2, 2015, the Committee heard presentations on the Neighborhood Council Program, and the Multi-Family Property Tax Exemption regarding Chapter 6A.110 of the Municipal Code. She then stated the Committee conducted interviews for the Landmarks Preservation Commission on March 2, 2015. Council Member Walker next stated the March 16, 2015 meeting included presentations on the Affordable Housing Policy and Advisory Group recommendations for updating membership and status of its work program, and the Housing and Urban Development (HUD) Annual Action Plan and Consolidated Plan recommendations. She noted the Committee held a special meeting on March 23, 2015, which included a follow-up presentation regarding the HUD Annual Action Plan and Consolidated Plan. She then provided information regarding a meeting by the Federal Reserve Bank to inform local banks of economic development and housing investment opportunities in the City that help with requirements for the Community Reinvestment Act. Council Member Walker concluded by stating the next meeting is scheduled for April 6, 2015, and will include presentations regarding the garage sale policy, West Slope Neighborhood Conservation District, and Landmarks Preservation Commission park name change.

Council Member Ibsen stated this Thursday Metro Parks Tacoma will host the third of four Destination Point Defiance town halls regarding the Point Defiance Park Master Plan, noting the meeting will focus on pedestrian, bike, vehicle circulation, and parking. Council Member Campbell provided information on community events in District No. 4, including the Urban Hike: Discovering Dometop on Foot event, and a town hall at Lincoln High School to discuss the City's Comprehensive Plan.

Council Member Woodards stated the University of Washington-Tacoma will be hosting an awards ceremony and discussion of "The Long Night" this Saturday in honor of Women's History Month.

Council Member Walker provided information on the Sister Cities International Film Festival, including films from France, the Philippines, and South Africa.
