

To: The City of Tacoma Mayor and City Council Members:
RE: WO18-0043

We, the undersigned, request our mayor and city council to halt planned construction at North 46th Street and Baltimore for the following reasons:

1. As of this date, August 30, 2021, not all residents who will be impacted by WO18-0043 Baltimore Street Project have been contacted. Those who were contacted by mail received written notification on or after August 12, even though notifications were dated August 6. This does not allow adequate time for feedback or concerns.

2. WO18-0043 Baltimore Street Project does not mitigate traffic issues Tacoma residents along Baltimore and North 46th Street encounter daily, which include excessive traffic, speeding on both streets, accidents and near misses at the N 46th and Baltimore intersection. It adds to our concerns because it will funnel more traffic through this residential corridor. WO18-0043 Baltimore Street Project's only purpose is to mitigate traffic in Ruston, created by current and future development projects in Point Ruston




















