## **SUMMARY AND PURPOSE:**

A resolution appointing individuals to committees that will prepare statements "For" and "Against" Proposition 1 (Streets Initiative II), concerning utility taxes and property tax levy rate, which will appear in the Voters' Pamphlet for the April 22, 2025, Special Election.

#### **BACKGROUND:**

**This Department's Recommendation is Based On:** The statutory requirement that the City appoint members to committees to prepare Voters' Pamphlet statements "For" and "Against" each measure placed on the ballot.

On December 17, 2024, the City Council adopted Resolution No. 41588, placing a proposition, concerning utility taxes and property tax levy rate for street improvements (Streets Initiative II), on the ballot for the April 22, 2025, Special Election.

The Government Performance and Finance Committee reviewed letters of interest at their regularly scheduled meeting on Tuesday, January 21, 2025, and provided recommendations for the appointment of individuals for the "For" and "Against" Committees for the proposition.

Per RCW 29A.32.280, for each measure from a unit of local government that is included in a local voters' pamphlet, the legislative authority of that jurisdiction shall, not later than the resolution deadline, formally appoint a committee to prepare arguments advocating voters' approval of the measure and shall formally appoint a committee to prepare arguments advocating voters' rejection of the measure.

## **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

The City reached out to the community to look for those interested in serving on the committees. Staff notified those who expressed interest in the topic as well as those on agenda notification, media, and Neighborhood Council contact lists; and advertised the request through the City's website, social media, and a news release.

#### **EVALUATION AND FOLLOW UP:**

Once the City Council appoints "For" and "Against" Committees, the City can submit all the required information to the County so that this proposition may be placed on the April 22, 2025, ballot.

The deadline for the City to send required information to Pierce County, including "For" and "Against" Committees, is February 21, 2025. The deadline for the Committees to submit their statements to Pierce County is Tuesday, February 25, 2025, with rebuttal statements due by February 27, 2025.

## **STAFF/SPONSOR RECOMMENDATION:**

Staff recommend the City Council appoint those members recommended by the Government Performance and Finance Committee to the Committees that will prepare statements "For" and "Against" Proposition 1, which will appear in the Voters' Pamphlet for the on April 22, 2025, Special Election.
