#### **ASSIGNMENT**



- Comprehensive Review
  - "make such recommendations to the City Council for change as the Committee may deem necessary and proper in order to amend the provisions of the existing City Charter with reference to improving the mode and manner of operation and efficiency in conducting the affairs of the City." (Res 41282)

## PROCESS PROCESS



- · City Council and CRC topic areas of interest
- Amplified Voices to Reach Consensus
- Excellent Internal Support and External Advisors
- Sustained Community Engagement
- Full CRC made all decisions collectively
- Seven teams were formed to advise the CRC by performing detailed research and analysis

### **RECOMMENDATION TOPICS**

- 24 Recommendations Approved
- Minimum Threshold for approval: 60% support
- 20 out of 24 reached 80% support
- 11 achieved unanimous votes

#### FORM OF GOVERNMENT



- "Executive Mayor" takes office January 2026
- · Mayor and Council hire Chief Administrative Officer
  - · Mayor supervises CAO
- · Full-time Council with independent staff
- Seven Member Council (starting in 2028)
- · Grants Mayoral Veto Authority
- · Grants Council Impeachment Authority

## POLICING ACCOUNTABILITY

- · Office of Policing Accountability to provide oversight
  - · Director appointed by, and reports to, Council
  - · Powers to be detailed by Ordinance
- Community Oversight Committee for Policing Accountability
  - Report on the activities and effectiveness of Office of Policing Accountability
  - · Engages the community and all branches of government

#### POWERS OF THE PEOPLE

- Ranked Choice Voting authorized
- Campaign Finance restrictions authorized
- Referendum Process: 90 days to gather signatures
- Initiatives: restrictions on placing competing proposals
- Neighborhood and Community Councils added to Charter

### **BOARDS AND COMMISSIONS**

- · Climate Commission created in Charter
- Landmarks Preservation Commission membership
- Planning Commission membership
- Aligns Salary Commission procedures with RCW
- Humane Society contracting reference deleted from Charter

### GOOD GOVERNANCE



- Council and Mayoral Term Limits extended
- "Purposes of Inquiry" language removed: clarifies how
  Council and Public Utility Board members can engage with staff
- Council to have more say in the hiring and firing of the City Attorney

#### FULL TIME COUNCIL



- Full-time City Council
  - · Authority to hire independent staff
  - · Grants explicit authority to investigate the executive branch

#### TACOMA PUBLIC UTILITIES

- Internet as a Utility
- One Board Member can live outside Tacoma
- Audit of Shared Services (TPU and general government)

## **MODERNIZED LANGUAGE**

- Eligibility for employment: strike citizenship requirement
- Employment anti-discrimination update
  - · Council required to periodically review and update Code
- Official Newspaper updated for "the internet age"
