FINAL READING OF ORDINANCES

Ordinance No. 28167

Amending Chapter 1.12 of the Municipal Code, relating to the Leave-Based Contribution Plan, to provide eligible employees an opportunity to voluntarily contribute the cash value of accrued vacation and/or personal time off to the United Way of Pierce County.

Ordinance No. 28168

Amending Chapter 12.08 of the Municipal Code, relating to stormwater and surface water systems, to authorize the Environmental Services Director to establish a pilot program to offer and evaluate the use of rebate payments to eligible customers, in an amount up to \$2,000, who construct and/or maintain City-owned low-impact development rain gardens and bioretention facilities through December 31, 2014.

FIRST READING OF ORDINANCES

Ordinance No. 28169

Amending Chapters 8.28 and 8.29 of the Municipal Code, relating to narcotics and drug paraphernalia, to add language relating to the public use and display of marijuana and medical cannabis, and revising the definition of drug paraphernalia to be consistent with state law.

Ordinance No. 28169 was set over for final reading on September 10, 2013.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee

Council Member Lonergan stated the Government Performance and Finance Committee has met three times since the last report. He stated the Committee approved the Telecommunication Franchise Agreement with Electric Lightwave LLC. He then stated that the Committee held a special meeting to select members of the "for" and "against" committees for City of Tacoma Proposition No. 1 ballot item. Council Member Lonergan stated the Committee was briefed on the SAP System Strategic Assessment, conducted interviews for the Board Ethics and heard the May monthly budget report. He noted the next meeting will be held on September 4, 2013, and will include an update on budget actuals through July.

Council Member Woodards announced the Tacoma Urban League, in conjunction with other organizations, is sponsoring a free community event which will feature a symbolic march, film and panel discussion, as well as activities for kids of all ages, in honor of the 50th Anniversary of the March on Washington. She encouraged everyone to participate in the event, stating it will begin in Tollefson Plaza at 5:30 p.m. with a march to the Washington State History Museum for the other events.

Council Member Walker announced that Community Health Care is having a fundraising event and luau in People's Park on Saturday, September 7, 2013, from 9:00 a.m. to 4:00 p.m., to support the new clinic on Earnest S. Brazill Street and Martin Luther King Jr. Way. She stated tickets for this event can be purchased through Community Health Care.

Council Member Ibsen announced the next Facts and Information Session regarding City of Tacoma's Proposition No. 1 will be held at Wheelock Library on Wednesday, September 4, 2013, at 6:00 p.m. in the Proctor District. He also stated the Pierce County Labor Council's picnic will be held at Ft. Steilacoom Park at 9200 Steilacoom Blvd Southwest, on Labor Day.

Council Member Boe announced the Stadium Fair Saturday, August 30, 2013, from 10:00 a.m. to 3:00 p.m. in the parking lot of the First Presbyterian Church, located at 20 Tacoma Avenue South. He then thanked the Maritime Fest for a great event this past weekend.

Deputy Mayor Campbell announced a parade in East Tacoma on Friday, August 30, 2013 from 10:45 a.m. through 12:00 noon, on Portland Avenue from 44th Street to 56th Street, to celebrate the return to the school year for the children.

Mayor Strickland stated that there will be no City Council study session, business meeting or Committee of the Whole next week.
