South Sound Manufacturing Industrial Council Update [Frank Boykin, Director, Manufacturing Industrial Council]

Deputy Mayor Blocker arrived here, at 10:02 a.m.

At approximately 10:02 a.m., Frank Boykin, Director, Manufacturing Industrial Council (MIC), presented an update regarding the MIC, including background; the MIC's mission, vision, approach, the organizational structure, and leadership team; challenges in 2021; transformations through strategic business initiatives; how the MIC will help drive efforts, noting advocating, informing, and engaging; what those efforts will mean for transformation; consequences ahead; anti-racist business; learning while growing; and contact information.

Discussion ensued regarding the MIC's perspective on making the TideFlats Interim Regulations permanent; heavily regulated zones; clarifying what is and is not allowed at the Port; having good information for policy decisions; what the MIC wants for the Tideflats; greener pathways; impacts of continuing

without change; rate issues; conditional use permits and proprietary information; how green manufacturing is defined; renewable fuels; uncertainty of the intent of the regulations; which industries fit with the economy; what green jobs are; regulatory uncertainties; MIC's strategic initiatives; the economic impact of the Tideflats; the Equity Index; the Planning Commission's recommendations, including the need for new recommendations and for a better understanding of the work they performed; not slowing the process any further; potential to hear further from the business community; discussing the potential Tideflats Subarea Plan and regulations further; a potential Committee of the Whole meeting; the MIC's interactions with the Planning Committee.
