COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Public Safety, Human Services, and Education Committee.

Council Member Campbell stated since the last report, the Public Safety, Human Services, and Education Committee heard a report from the Tacoma-Pierce County Health Department on the development of a county-wide health assessment and a community health improvement plan; received a presentation on Tacoma Fire Department's 2014 – 2018 Strategic Plan; and heard a presentation on the new Derelict Vessels Program and private public partnerships for Harbor Code enforcement. He stated the Committee also received presentations from Seattle City Club on findings and recommendations from its 2014 Civic Health Index, from Safe Streets on their 2014 – 2017 Strategic Plan; the Human Rights Commission; 2014 legislative actions; Neighborhood and Community Services' Courage Initiative; and Childcare Aware presented information on initiatives related to Tacoma Public Schools and literacy in the Hilltop community. He stated at the next meeting, the Committee will hear a presentation from the Citizen Review Panel.

Council Member Boe shared the schedule for the local farmers markets, stating the 6th Ave Farmers' Market is every Tuesday afternoon; the Broadway Farmers' Market is every Thursday; the Proctor Farmers' Market is every Saturday morning; and the South Tacoma Farmers' Market is every Sunday. He stated the next Walk Tacoma event from Downtown On the Go is Wednesday, June 18, 2014, beginning at 5:15 p.m. at Fireman's Park for the public art walk, followed by a social hour at the Forum. He also noted the Knights of Pythias Lodge on Broadway invites everyone to stop by while they are at the Broadway Farmers' Market for a tour of their historic lodge; and this weekend, the Tacoma History Hike will be a history-themed scavenger hunt around downtown Tacoma.

Council Member Campbell announced that the community cleanup for the Stewart, Spring Hill, and Mann neighborhoods will be this Saturday, June 21, 2014 from 10:00 a.m. to 2:00 p.m. He also invited everyone to stop by Tollefson Plaza this Saturday starting at 10 a.m. for Go Skate Tacoma, a celebration of skateboarding.

Council Member Lonergan announced that the community cleanup for the East Wapato, Park Avenue, Baker, Birney, Hillside, and Pac West area will also be this Saturday from 10:00 a.m. to 2:00 p.m.
