

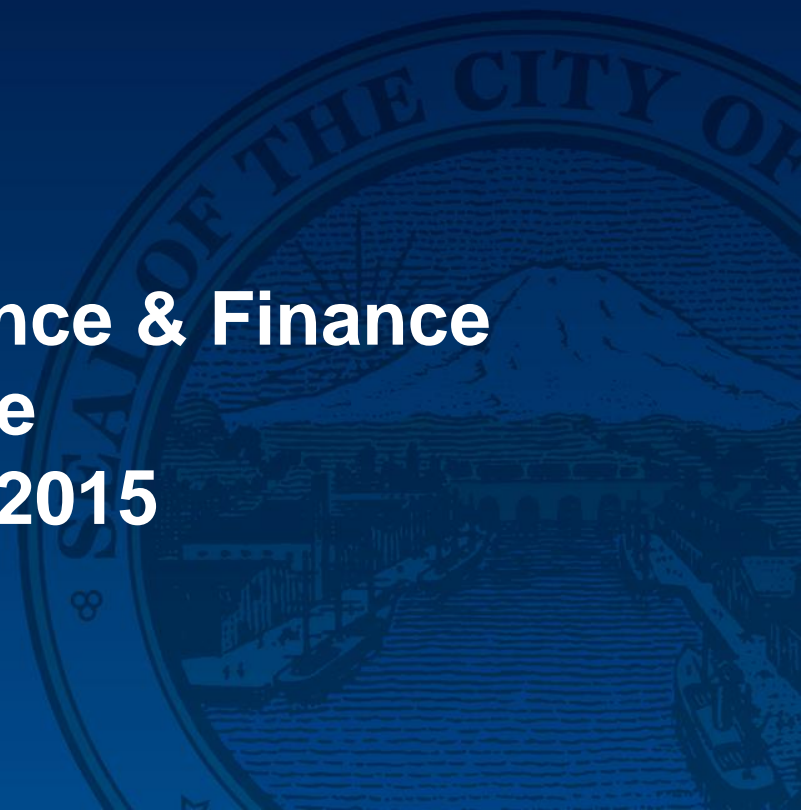

Overview

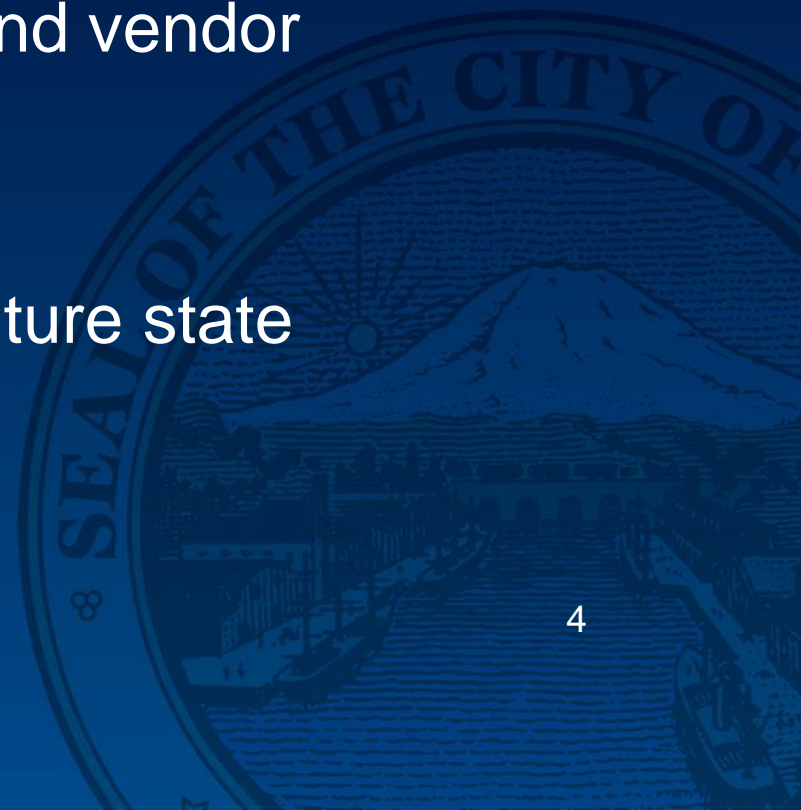
- Procure2Pay Project
 - Eliminate manual and inefficient procurement and payment practices
 - Deploy web based software that is integrated with SAP which improves reporting, spend analysis, and drives contract compliance
 - Save the City money through strategic procurement decisions

Background

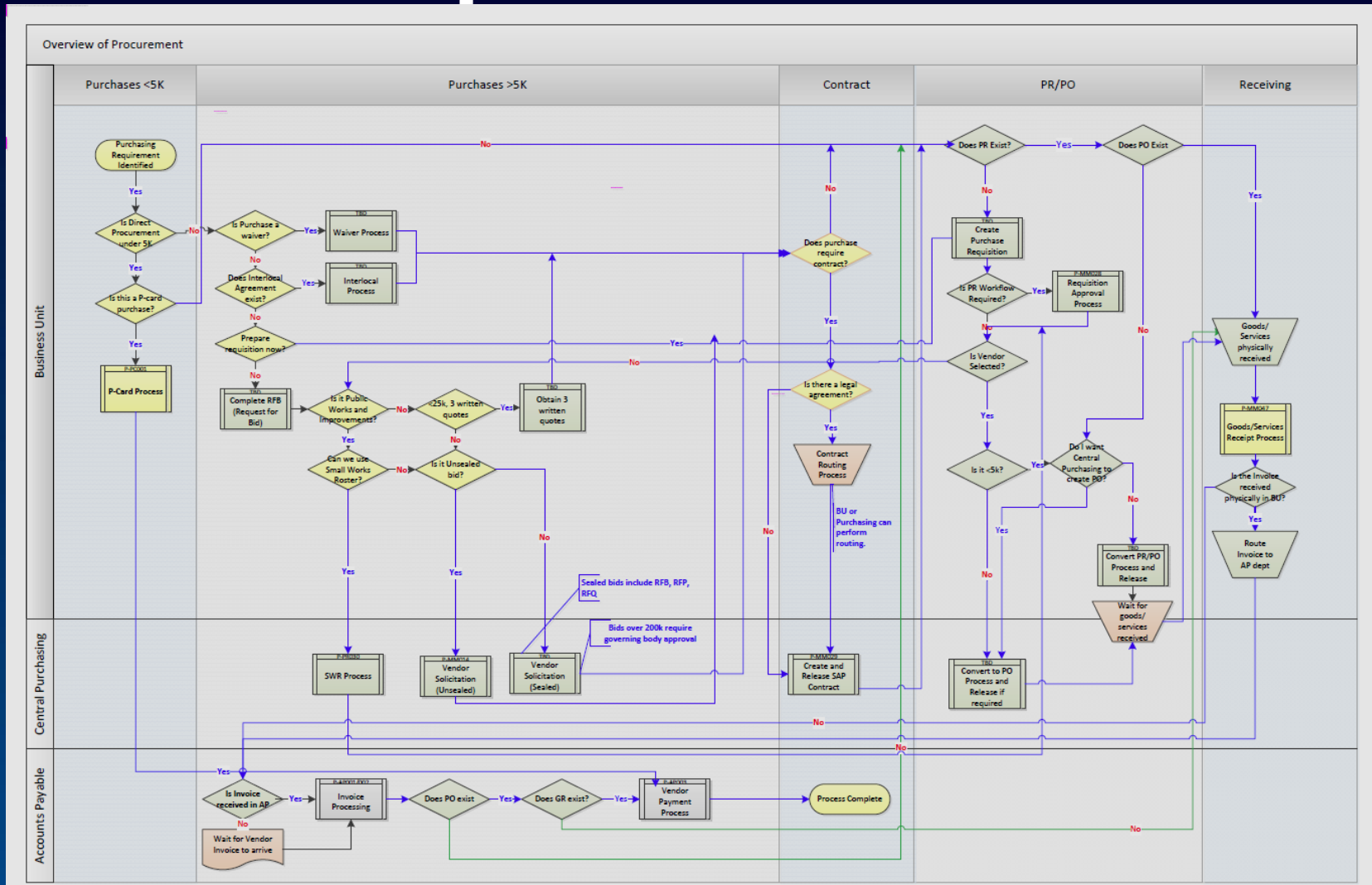
- 2014 - Sage Consulting recommended review of current SAP functionality
- 2015 - Procure2Pay team established
 - Blueprinted procurement and payment processes
 - Engaged customer feedback group to identify pain points
 - Policy/governance review
 - Develop master data standards and clean up vendor master

Background (continued)

- Address reporting capability/needs
- Procurement and payment best practices
- Customer workshops and vendor outreach
- Address staffing levels
- Develop road map of future state



It's Complicated...



2014 Metrics

\$300 Million in POs

- **95% of our spend cannot be measured, analyzed or reported**
 - \$284.5 Million in text-only POs
 - Master data, where it exists, is not standardized
- **700 Competitive bid processes**
 - Approximately twice the average of similar organizations

2014 Metrics

- **No vendor portal for PO's/invoices or pre-registration for bids**
- **57,000 invoices were hand entered into SAP for payment**
 - No capability to receive invoices electronically
 - 96% routed directly to departments instead of AP
 - 33% returned back to departments for corrections

Goal and Recommendations

- Over the next 5 years, enable strategic procurement to leverage our spend and save

\$10 to 15 million

- Deploy an easy and intuitive web-based user interface for both the vendors and the City

Benefits of Solution

- In the future the City will have:
 - Amazon-like ordering, improved visibility of City contracts.
 - Electronic receipt of bids, transmittal of POs and receipt of invoices
 - Streamlined workflow routing and approvals
 - Ability to pay invoices more quickly
 - Improved spend analysis, reporting and drives contract compliance

Benefits of Solution

- Our vendors will have:
 - Access to vendor portal, where they may self register for notification of City of Tacoma bids, electronically submit bid responses, receive POs, and submit invoices
 - Faster payment process
 - Access to a nationwide network of potential customers
 - Increase the vendor community's satisfaction with the City's processes

Project Status

- Vendor Master cleaned up
- BPC and ISGB approval for the project
- RFP in bid open status
- Project manager selected
- Holding requirement workshops with departments
- Budget secured for \$1.6 million
- Phased implementation rollout
