Deputy Mayor Walker proclaimed Thursday, October 19, 2023, as Community Conflict Resolution Day and presented the proclamation to Maralise Hood Quan, Executive Director, and Michael Transue, Board of Directors President, Center for Dialog and Resolution. **6. 23-1008** Recognizing the 10th Anniversary of the City's Customer Support Center and Tacoma FIRST 311.

Deputy Mayor Walker recognized the 10th Anniversary of the City's Customer Support Center and Tacoma FIRST 311 and presented the recognition to La'Toya Mason, Principal Customer Service Analyst, City Managers Office.

7. 23-1011 Presentation from the City Manager regarding Systems Transformation, including highlights from the Planning and Development Services Department and Public Works Department's racial equity action plans.

City Manager Elizabeth Pauli provided opening remarks on systems transformation and introduced Peter Huffman, Director, Planning and Development Services (PDS). Huffman presented an overview of PDS's service delivery and engagement; how the workforce reflects the community, noting the racial and demographic diversity of PDS employees; next steps and challenges; and the 2023 planned action visual, noting the past, present, and future plans to continue equity in hiring efforts and pilot programs to meet and assist customers in their communities. Jeff Jenkins, Assistant Director, Public Works (PW), provided opening remarks and presented Public Works' racial equity action plan goals, noting workforce demographics reflecting the community it serves, equitable outreach and communications, and equitable service delivery and infrastructure investments. He continued by reviewing how the workforce reflects the community, noting the intent, specific tasks included, the racial and demographic diversity of employees as of second quarter of 2023 and trends from 2018 to 2023, progress made for the workforce demographic goal, the PW equity mission statement, and next steps. He continued by outlining equitable outreach and engagement, noting the intent, specific tasks included, and past examples; and equitable service delivery, noting the intent, specific tasks included, and progress made for this goal. Jenkins continued by outlining the 2023 planned action visual, noting the past, present, and future actions to diversify the job candidate pool and to take advantage of the SAP Now! project to completely revamp their asset management capabilities. City Manager Pauli concluded by presenting recent accomplishments, upcoming community engagements, and the transformation timeline and history.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Community Vitality and Safety Committee

Council Member Ushka, Chair of the Community Vitality and Safety Committee, reported at the September 14, 2023, meeting, the Committee conducted additional interviews for the Tacoma Area Commission on Disabilities and received a presentation on the Mental Health and Substance Use Disorder sales tax; and on September 28, 2023, the Committee received presentations on the Crystal Judson Family Justice Center and the use of health metrics to achieve health equity and environmental justice. She concluded by stating the next meeting will be held in a hybrid format on October 26, 2023, at 4:30 p.m., and will include presentations on a proposed amendments to Tacoma Municipal Code Chapter 8.17 and the Rental Housing Code additional research work plan.

Economic Development Committee

Council Member Blocker, Chair of the Economic Development Committee, stated that the Committee has not met since the last report, and that there is one correction to last month's report, noting that on September 26, 2023, the Committee reviewed staff's recommendations regarding business license fees in 2025 and 2026 as outlined in Ordinance No. 28838, and the Ordinance added two new license tiers based on gross income and increased business license fees in 2023 and 2024. Council Member Blocker concluded by stating the October 10, 2023, was cancelled; and the next meeting will be held in a hybrid format on October 24, 2023, at 10:00 a.m., and will include a presentation on the 2023 Black, Indigenous, and People of Color Alliance feasibility study recommendations.
