1. Call to Order

2. Consent Agenda

3. Public Comment on Agenda Items 2:15 pm

4. Welcome 2:16 pm

Commissioners Gilmore and Takla welcomed everyone and shared that the purpose of the retreat was to connect and learn about each other; build trust amongst commissioners and staff in a safe space; do some collective visioning, dreaming, and ideation; understand each other's spheres of influence; and leave with an action.

5. Land Acknowledgement and Quiet Reflection 2:17 pm

Staff shared the Land Acknowledgement:

ʔuk'wədiitəb ʔuhigwətəb čəʔ txwəl tiit ʔa čəʔ ʔal tə swatxwixwtxwəd ʔə tiit puyaləpabš dxwəsətəʔlils gwəl ʔutxwəlšucidəbs həlgwəʔ.

We gratefully acknowledge that we rest on the traditional lands of the Puyallup People where they make their home and speak the Lushootseed language.

Staff led an exercise in quietly reflecting on the land we are on.

6. Show and Tell: Sharing Our Passions 2:22 pm

Commissioner and staff took turns introducing themselves and sharing an arts, culture, heritage, science, or community-minded passion they have.

7. Exquisite Tree Exercise 2:56 pm

Commissioners and staff broke into four small groups, each focused on one of these purposes of the Commission:

- Promote and support a diversity of arts and cultural opportunities for our citizens to experience (TMC 1.28A.030b)
- Create a unique identity and sense of place through the development and stewardship of public art. (TMC 1.28A.030e)
- Fund programs that encourage artistic excellence and expand exposure to a wide variety of art forms. (TMC 1.28A.030f)
- Foster the development of the local arts community, encouraging an environment for the success of working individual artists. (TMC 1.28A.030g)

Groups worked collaboratively to create a tree image and discussed these prompt questions as they related to their purpose:

- What elements are essential for long-term success? (Roots)
- What are we currently doing in this area? (Trunk)
- How can we further develop these ideas? (Branches)
- What are we seeing or can expect to see as a result of our work (Leaves and flowers)
- What are new ideas that we might develop and nurture? (Seeds)

8. Root Care: Advocacy

3:30 pm

Groups brainstormed personalized advocacy statements that can be used during Council Coffee meetings. Statements tied to Council Priorities and focused on these foundational needs:

- Public Art Staffing
- Arts Funding Budget
- Tacoma Creates Reauthorization
- Tacoma Public Utilities' Participation in the 1% for Art program

9. Wrap Up and Reflection

3:50 pm

Groups shared out some highlights from their discussions and some personalized advocacy statements they developed.

Some of the ideas shared include:

- An increase in arts funding will support being in a community and bringing people together, improving connections and safety. Artist funding opens pathways to diverse opportunities for professional practice.
- Public Art encourages gathering and provides a means to welcome people in. Public art also promotes traffic and pedestrian safety; public art saves lives.
- Sharing testimonials/quotes from some of the organizations funded through Tacoma Creates to show the tangible impact this funding is having in Tacoma.
