Call to Order

Mayor Woodards called the study session to order at 12:11 p.m.

Briefing Items

1. <u>18-0085</u> Legislative Session Updates

At approximately 12:12 p.m., Randall Lewis, Government Relations Officer, provided a legislative update related to the status of the City bills of interest, budget issues, and the timeline. Mr. Lewis further reviewed the City bills of interest, including House Bill (HB) 2813 / Senate Bill (SB) 6418, which created a new version of the commercial office incentives; HB 2880 / SB 6487, regarding Point Ruston, noting it still needs amendments; HB 1114 / SB 6320, regarding leasehold excise tax, noting a Tacoma Dome requirement and exemption; HB 2201 / SB 5955, which includes a new schedule for Sound Transit Motor Vehicle Excise Tax and provide rebates for people who paid the higher schedule in 2017 or 2018; HB 2057 / SB 6484, references abandoned homes, noting it increases cost recovery and provides a new process for foreclosed homes; HB 2006, which creates flexible revenue for mental health tax and levy lid; HB 2592 / SB 5935, describing two approaches to small cells; HB 1800 / SB 6002, which changes local elections under the Voting Rights Act; and HB 1570, which increases the document recording fee. Mr. Lewis discussed the capital budget, including local projects, the City's interest in acquiring properties, and amendments being sought in the Supplemental Capital Budget; and reviewed upcoming dates. He concluded by reviewing the clean air bills HB 2601, 2602, and 2603, noting clean air in the port regions, and described a legislation regarding police body cameras.

Discussion ensued regarding smalls cells, local projects in the capital budget,

and impact fees on affordable housing bills.

Other Items of Interest

2. <u>18-0108</u> Request for a Comprehensive Review of Provided Town of Ruston Services

Council Member Mello stated he sent out an inquiry letter regarding Point Ruston and the Town of Ruston, mentioning and inquiring about protecting our rate and taxpayers, permitting certainty for Point Ruston, rate and taxpayer fairness, services provided by the City to the Town of Ruston that are or are not reimbursed, and who responds to and who reimburses emergency service incidents and utility services.

Discussion ensued regarding comparison of other cities service arrangement charges.

Council Member McCarthy discussed the Opioid Summit held this Friday, February 2, 2018, noting registration is still open to participate; background, including outreach and an action agenda; presenters and information provided at the event; and participation from cities in Pierce County and fire and police departments.

Council Member McCarthy discussed the consideration of an amendment to Resolution No. 39930 relating to Click!, noting partnership, financial feasibility, recent approach on the business model, and legal feasibility.

Discussion ensued regarding clarification on the terms of utility and enterprise, proposed language, use of correct terminology, financial feasibility, and current resolution language.
