#### SUMMARY AND PURPOSE:

Nominating and electing Council Member John Hines to the office of Deputy Mayor to serve a one-year term to expire December 31, 2024.

## **BACKGROUND:**

Council Member Kristina Walkers' term as Deputy Mayor expired on December 31, 2023. Council Member John Hines' interest in serving and seniority status qualifies him as a candidate for Deputy Mayor.

Per Ordinance No. 26767, the Deputy Mayor shall be a member of the City Council and shall be elected by the Council at its first meeting after such office becomes vacant, or as soon thereafter as practical. The term of such office shall be for one year.

## **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

Mayor Woodards met with individual Council Members to understand their availability to serve and interests prior to bringing this resolution.
