# COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee

Council Member Lonergan stated the Government Performance and Finance Committee has met three times since the last report and during those meetings, the Committee received July and August budget reports, an update on the Multi-City Tax Portal, and received presentations on the City's 2012 Federal Program Audit and on the Limited Area Franchise Agreement between the City and LightSpeed Networks, Inc. that will be considered at the October 29, 2013 Council meeting. He stated the Committee also received an update on the work of the Fiscal Sustainability Task Force, noting the Task Force is finalizing its recommendations and will present those recommendations to the Committee in

#### December.

Deputy Mayor Campbell announced upcoming events, the first entitled "FLAVOR", a dine-out fundraiser for Tacoma Community House. He noted 25 percent of each bill will be donated to support programs at Tacoma Community House for dining at participating restaurants on Thursday, October 24, 2013. He stated more information and the list of participating restaurants can be found at: tacomacommunityhouse.org. He also stated on Friday, November 1, 2013, those who dine at Taquieria El Antojo and mention Project MoLE, through the Northwest Leadership Foundation, 25 percent of the bill will be donated to the program. He then announced upcoming Harvest Fest events hosted by Metro Parks Tacoma.

Council Member Woodards announced the City's gang prevention project recently received a \$133,000 grant from the State of Washington.

Council Member Walker stated November is the annual Art at Work Month, and the opening party and Amocat Awards will be held at the Foss Waterway Seaport on Monday, October 28, 2013.

Council Member Boe provided a brief update on the Pacific Avenue Streetscape Project.

Council Member Thoms announced the screening of the documentary "American Winter" on October 24, 2013, at the Grand Theatre. He stated the film follows the personal stories of eight families struggling in the wake of the economic downturn. He noted a reception will be held afterward at Corrina Bakery.

Council Member Ibsen stated the 2013 Excellence in Affordable Housing Awards will be held on October 23, 2013, at Annie Wright School.
