

ORDINANCE NO. 29037

AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the Tacoma Municipal Code to implement rates of pay and compensation for non-represented employees and employees represented by the Brotherhood of Locomotive Engineers and Trainmen; and declaring the effective dates thereof.

BE IT ORDAINED BY THE CITY OF TACOMA:
