### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Community Vitality and Safety Committee

Council Member Blocker, Chair of the Community Vitality and Safety Committee, reported on November 9, 2017, the Committee interviewed applicants for the Human Rights Commission, heard a presentation and requested further discussion on the creation of a Commission on Immigrant and Refugee Affairs, heard a presentation on and recommended proposed changes to the residential infill pilot program from Planning and Development Services, and heard a presentation on and recommended a Council Consideration Request from Council Member Walker Lee that would allocate \$50,000 from the Council Contingency Fund to support Tacoma Housing Authority's pilot project for providing incentives for landlords who take Section 8 youchers.

Council Member Blocker reported the meeting on November 23, 2017 was cancelled, and a special meeting was held on November 29, 2017, where the Committee heard a presentation on and recommended a draft resolution from Council Member Campbell creating a Commission on Immigrant and Refugee Affairs, scheduled for consideration by the full Council on December 12, 2017. Finally, he reported the next meeting will be December 14, 2017, and will include interviews for the Citizen Police Advisory Committee.
