Parking Initiative Update

[Dana Brown, Assistant Division Manager, Public Works]

At approximately 5:38 p.m., Dana Brown, Assistant Division Manager, Public Works (PW), made opening remarks and provided information relative to the City's parking system, including an overview on competencies of the parking system, history, and the Parking Enterprise Fund and its funded projects. Eric Huseby, Parking Services Manager, PW, provided information on the parking initiatives that are in progress, including the residential parking program and enhanced parking enforcement system, and reviewed the new online warning system which tracks issued warnings. He then provided information on the City's work with the Parking Technical Advisory Group, including development and implementation of the Downtown parking system and its expansion, the residential parking program, and upcoming projects. He concluded by providing information on the parking system branding initiative in an effort to differentiate the City's parking system from other entities in Tacoma.

Discussion ensued regarding the number of Parking Enforcement Officers, the annual labor cost on parking enforcement, parking citation fees collected per year, punitive parking system for people who cannot afford the tickets, the goal of the parking system, relations between the City's parking system and the court system, and warnings versus citations.

6. [17-0971](#) Model Traffic Ordinance Update  
[Josh Diekmann, Assistant Division Manager, Public Works]

At approximately 5:58 p.m., Josh Diekmann, Assistant Division Manager, PW, made opening remarks and provided information on the proposed changes to the Model Traffic Ordinance, including an overview, background, and issues. He stated the proposed amendments include clean up to previously approved revisions to Title 11 of the municipal code, relating to the Model Traffic Ordinance, updates to the existing conditions, change in speed limits, and changes to South 32nd Street westbound and Pacific Avenue. He then stated the new proposed amendments, which are in regards to parking of commercial vehicles in residential neighborhoods, vehicular weight, penalties, and automated traffic safety cameras. He concluded by reviewing outreach efforts and next steps.

Discussion ensued throughout the presentation regarding speed limits, potential controversies, and outreach efforts.


