SUMMARY:

The Information Technology Department recommends authorization of four, three-year master ("bench") contracts for supplemental SAP implementation and support services, at a total not-to-exceed cost of \$1,900,000. Vendors are Avertra Corporation (Herndon, VA), Sage Group Consulting, Inc. (Hazlet, NJ), Apex Systems (Bellevue, WA), and Phoenix Business, Inc. (Haltom City, TX). The expected contract terms would be from May 1, 2015 to May 1, 2018 with possible extensions through May 2020.

STRATEGIC POLICY PRIORITY:

• Encourage and promote an open, effective, results-oriented organization.

BACKGROUND:

The City of Tacoma has provided in-house SAP support since 2003. Since that time, there has been steadily growing demand to improve the City's utilization of SAP technology and business functionality. Traditionally, supplemental service contracts have been established on a per-project basis by developing unique contracts for each statement of work.

ISSUE:

The current staff augmentation contracting process adds months to the project lifecycle for each technology initiative and is not useful in filling temporary staffing gaps.

Establishing reusable "bench" contracts for supplemental SAP services will improve efficiency and agility for the Information Technology Department to accommodate dynamic customer needs, to fulfill niche technical skillsets, and to deliver approved business modernization projects in 2015-2016. Task assignments for the areas of procurement, human resources, finance/budget, and employee retirement services will be issued according to project need.

ALTERNATIVES: An alternative action is to issue separate and distinct request for proposals and subsequent contracts for each project assignment. Establishing reusable bench contracts for supplemental SAP services as needed will better accommodate dynamic workloads, customer needs, and planned innovation projects, saving time in delivery.

COMPETITIVE SOLICITATION: SAP Technical and Functional Consulting Services, Specification No. IT14-0576F was opened 11/18/2014. Forty (40) companies were invited to bid in addition to normal advertising of the project. Twenty-nine (29) submittals were received. Four (4) vendors were selected to enter into contracts for three-year, master "bench" contracts as a result of the RFP competitive bidding process.
