Call to Order

Mayor Strickland called the study session to order at 12:11 p.m.

Briefing Items

1. 14-0533 Gun Safety Education Campaign

Mayor Strickland announced the first study session topic is the gun safety education campaign. Melissa Cordeiro, Neighborhood and Community Services, reviewed the campaign, including background information, messaging, and key components.

Council Member Campbell arrived here, at 12:15 p.m.

Ms. Cordeiro continued to review the campaign, including key activities and strategies, national statistics, partnerships, and next steps. Discussion ensued regarding anonymous gun surrender, partnerships with local gun shops, potential partnerships with domestic violence partners, whether the campaign will offer education to adults with children in the home, and the opportunities to educate citizens on safe gun storage. Deputy Mayor Woodards and Council Member Campbell requested additional information regarding the anonymous gun surrender programs, including the process for turning in guns. Assistant City Manager Tansy Hayward stated the campaign will include a clear definition of what safe and anonymous surrender means and directions on how to participate in the process. Mayor Strickland suggested staff review the Give 5-0 the 411 campaign in Washington, D.C., which allows community members to anonymously text tips to the Metropolitan Police Department.
