 16-0337 Plastic Bag Model Ordinance [Kristin Lynett, Sustainability Officer, Office of Environmental Policy and Sustainability]

At approximately 5:32 p.m., Kristin Lynett and Jim Parvey, Environmental Services, provided an overview of the proposed ordinance relative to shopping bag restrictions and results of additional outreach, including timeline, issues, limiting the use of single-use carryout bags, bag restrictions, the Bellingham model, feedback, received continued outreach, definitions, exemptions, implementation, and fiscal impact.

Discussion ensued throughout regarding bags provided to low income families, types of bags allowed per the ordinance definitions, distribution to Tacoma public schools and the Tacoma Housing Authority, hidden costs, recovered costs, potential impacts, and estimated costs.
