Clarissa Gines provided an update the 2024-25 funding application cycle, and shared that 92 applications were received.

Lisa Jaret shared that an offer has been accepted for the Arts & Cultural Vitality Division Manager position, with a start date of May 20th. She also shared details on upcoming and going projects, which include the JEDI (Justice, Equity, Diversity, and Inclusion) Film Series, Teaching Artist Training Lab, capacity building work with CPIN (Collaborative Partners Initiative Network), and Elevate Health.
