Council Member Daniels arrived here, at 4:32 p.m.

At approximately 4:33 p.m., Raeshawna Ware, Senior Policy Analyst, Office of Equity and Human Rights (OEHR), provided opening remarks and introduced Lisa Woods, Director, OEHR; and Emani Donaldson, Chair, Alma Villegas, Vice Chair, and Maricres Valdez Castro, Commissioner, Commission on Immigrant and Refugee Affairs (CIRA). Together, they presented the CIRA end-of-year report, including an overview; background; highlights and achievements; community relations; CIRA sub-committee areas of focus, noting the governance committee and community safety committee; recommendations, noting challenges, current actions, proposed actions, and accountability expectations; welcoming efforts, noting an overview of how the City is connected to Welcoming Week and resources

around immigrant and refugee experience; a request for Council Members to sponsor a Council Consideration Request (CCR) for use of the Council Contingency Funds to send two Commissioners and a Council Member to the Welcoming Interactive conference with OEHR staff; and CIRA's request for direction from the Community Vitality and Safety (CVS) Committee.

Discussion ensued regarding an update on and improvements for the Tacoma Police Department's translation application; achievements relating to the Language Access Plan and support for those detained in the Northwest Immigration and Customs Enforcement Processing Center; areas of focus through the CIRA community safety committee, noting Blue cards; recommendations, noting Commissioner participation in the committees, boards, and commissions (CBC) interview process; the CCR request; collaboration with other CBCs; CIRA meetings; and the questions seeking direction from the CVS Committee for CIRA.

There were no other items of interest.


## Adjournment
