•••• BACKGROUND – WHAT ARE THEY?

- · Tool to address the impacts of growth
- · One-time charge assessed against a new development
- · 4 types: transportation, fire, schools, parks
- · Impact fees fund:
 - · Capital system improvements
 - · Projects on a jurisdiction's capital facilities element
 - Cannot pay for:
 - · Ongoing costs, such as maintenance
 - Existing deficiencies
 - · Project needs caused by growth outside of a jurisdiction
 - 100% of project cost

- September 2018 Impact Fees
 - Code evaluation and applicability to Tacoma
 - · Summary evaluation of impact fees for each type
- November 2021 Impact Fee Framework Study
 - · Developed a potential framework
 - Readiness of each type
 - Recommendation to further evaluate transportation impact fees

PROGRAM CONSIDERATIONS



- Capital project eligibility
 - \$399M in eligible transit, pedestrian, bicycle, and motorized projects
 - \$342M in potential pedestrian, bicycle, and motorized projects
- Exemptions/reductions
- · Geographical areas/zones
 - Citywide or subareas
- · Alignment with other programs
 - Multifamily Tax Exemption
 - Off-site Improvements

***NEXT STEPS



- Develop Request for Proposals to:
 - Evaluate capital projects for eligibility
 - Perform focused capital planning in areas that lack identified projects
 - Define capacity based on person trips as opposed to vehicle trips
 - Refine forecasts for bases of a fee program
 - Develop zones to support equitable fee structure
 - Leverage Tacoma's Equity Index in structuring the program
- GOAL: Develop Fee Schedule that meets the City's priorities
