On July 31, 2012, the City Council amended Chapter 8.30 of the Tacoma Municipal Code relating to cannabis as a public nuisance. With the passing of Initiative 502 on the November 6, 2012, general ballot, amendments to Substitute Ordinance No. 28083 are warranted per Exhibit A. The State has adopted rules and regulations which are required to be in place by December 1, 2013, which prompted the City to amend TMC Chapter 8.30.
