SUMMARY:

The Environmental Services Department recommends a contract be awarded to low bidder Miles Sand & Gravel Company, Puyallup, WA, in the amount of \$227,760.00, not including sales tax, for sand used in the creation of TAGRO soil amendment on an as-needed basis, for an initial two-year term with the option to renew for three additional one-year terms, for a projected contract total of \$569,400.00, not including sales tax.

STRATEGIC POLICY PRIORITY:

- Assure outstanding stewardship of the natural and built environment.
- Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

The City of Tacoma TAGRO products provide for the recycling of 100 percent of the biosolids produced in the City of Tacoma.

BACKGROUND:

ISSUE: Sand is a necessary ingredient in making TAGRO Mix and related products at Tacoma's Central Wastewater Treatment Plant. TAGRO is an organic, manufactured soil amendment made with dewatered biosolids "cake," sand and sawdust. It is available to residential and farming communities for use on lawns, landscaping, gardens and some pasturelands. The final product is put on citizens' lawns and yards.

ALTERNATIVES: An alternative would be to not award this contract and either go out to bid again, or research a substitute raw material and in the meantime stop making TAGRO, as sand is required raw material. TAGRO generates approximately \$580,000 annually.

COMPETITIVE SOLICITATION: Request for Bids Specification No. ES15-0595F was opened November 3, 2015. Several companies were invited to bid in addition to normal advertising of the project. The low bid was submitted in cost per ton and converted to cost per cubic yards to be consistent with the other submitted bids. Three submittals were received. The table below reflects the amount of the initial contract term.

CONTRACT HISTORY: New contract.

SUSTAINABILITY: City of Tacoma TAGRO products provide for the recycling of 100 percent of the biosolids produced in the City of Tacoma. The sand is acceptable for use as an ingredient in making TAGRO soil amendment products at Tacoma's Central Wastewater Treatment Plant. TAGRO is an organic soil amendment, manufactured with dewatered biosolids, sawdust, and sand. The highest quality raw materials are required to meet the product quality standard for TAGRO products.
