## **DIRECTOR'S REPORT**

The Director updated information on:

- 1. The second stage of the RFID project is included in the 2016 biennial adjustment to the City of Tacoma's 2015/2016 budget. The project includes digital wands, ADA compliant self-check with credit card capability and instructions in seven languages.
- 2. McCarver Project: Work continues to develop a pilot project to extend the hours available to students and their caregivers to use resources at the McCarver Elementary School library through a partnership with Tacoma Public Library.
- 3. In partnership with the library, House of Matthew presents the Homeward Bound Program to support people who are homeless or in imminent danger of becoming homeless. The CEO of House of Matthew, Jeannette Twitty, received the Best of Tacoma Award for transitional services.
- 4. Pathway Card is operational for students in all grades in the Tacoma Public School District.
- 5. Mayor Strickland has selected **Station Eleven** by Emily St. John Mandel for the Tacoma Reads 2016. The programming will run through March and April 2016. The author will be coming to Tacoma on March 24, 2016.
- 6. IT Manager Christine Bassett gave a demonstration of the new website to the Trustees. The soft launch will be November 30, 2015 with a link on the current website to the new one. Full roll out is expected to be January 18, 2016 when the current website will be completely replaced with the new site.
