Chair Ushka called the meeting to order at 4:33 p.m.

Briefing Items

1. <u>21-0716</u> American Rescue Plan Spending Buckets
[Reid Bennion, Lead Analyst, Office of Management and Budget]

At approximately 4:34 p.m., Reid Bennion, Lead Budget Analyst, Office of Management and Budget, gave a presentation on American Rescue Plan Act (ARPA) spending buckets, including an overview, purpose, 2021 ARPA distributions, a community safety funding summary, a health funding summary, an example of next steps, and a timeline.

Discussion ensued throughout regarding issues with the process, projects not receiving funding, body worn and dash camera funding sources, funds available to nonprofits, the total number of requests from nonprofits, farmers market funding, desired Committee feedback, differences between the domestic violence system web based resource and legal advocacy, impacts of changing proposed funding, leftover funds, and whether there are other projects not listed in the presentation.

2. <u>21-0717</u> Body Worn and Dash Cameras

At approximately 5:07 p.m., Matt Janzow, Continuous Improvement Analyst, Human Resources, and Mr. Bennion and presented on body worn and dash cameras, including Tacoma ARPA spending objectives, 2021 ARPA proposed distributions, community informed action, body worn and dash camera expansion, camera footage examples, an implementation timeline, and a community safety funding summary.

Discussion ensued regarding current implementation of body worn cameras, and a request for a cost breakdown analysis for both camera types.

3. <u>21-0721</u> Eviction Moratorium

At approximately 5:18 p.m., ChiQuata Elder, Lead Program Development Specialist, Office of Equity and Human Rights; Jacques Colon, Tacoma 2025 Strategic Manager, Media and Communications Office; and Steven Sawada, Senior Continuous Improvement Analyst, Human Resources, presented on the eviction moratorium, including background information, rental assistance and outreach, proposed changes to Tacoma Municipal Code (TMC) Chapter 1.95, eviction risk data and rental housing mapping, cursory research on local eviction moratoria, fiscal impacts, and recommendations.

Discussion ensued regarding outreach, using the National League of Cities' Eviction Prevention Lab data, just cause eviction policy implementation concerns, and the timeline for TMC changes.
