SUMMARY AND PURPOSE:

A resolution authorizing a Council Contingency Fund expenditure of up to \$7,000 to sponsor the Summer Coding Workshop Series developed by the Lifelong Kindergarten group at the Massachusetts Institute of Technology (MIT) Media Lab and hosted by Tacoma Public Libraries.

BACKGROUND:

The Summer Coding Workshop Series will provide a diverse range of young people in Tacoma with the opportunity to explore and learn how to use a new block-based coding app being developed by the Lifelong Kindergarten group at the MIT Media Lab. The app allows users to take photos and record sounds, and then bring them to life with code.

The Summer Coding Workshop Series will help participants build a wide variety of skills, including learning coding work and creative thinking. During the workshop, participants will create games, stories, and animations to reinforce learning from books read in the Tacoma Public Library Summer Reading Program. Books selected for this workshop will focus on amplifying stories from marginalized communities, including people of color, women, and people with disabilities. This new block-based coding language is set to be officially released in the fall of 2023, giving Tacoma's youth the opportunity to be amongst the first group of people to create using the app.

This funding would allow the City to sponsor the Summer Coding Workshop Series. This sponsorship would enable Lifelong Kindergarten to purchase twenty 9th Generation iPads for the Summer Coding Workshop Series at an educational price of \$309.00 per iPad and critical accessories. The sponsorship would also include a memorandum of understanding between Lifelong Kindergarten and Tacoma Public Library for the iPads to be donated to the Library after the conclusion of the workshop series. The technology currently available for use at the Tacoma Public Libraries does not allow for patrons to participate in collaborative creative learning activities, such as mobile coding or drawing/animating with tools such as Procreate and Scratch.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

The Summer Coding Workshop Series will be held at a variety of Tacoma Public Library locations to reach a diverse group of participants. Workshop dates and Tacoma Public Library locations include:

Two Tacoma Public Schools students - Jaylen Leonard (IDEA 2023) and Zion Jackson (SAMI 2027) - will participate in a summer internship with the Lifelong Kindergarten group, during which their main responsibilities will be to codesign coding activities and co-facilitate the workshops. In addition, the workshop facilitator, Jaleesa Trapp, grew up in Tacoma and attended Foss High School. She is now a PhD candidate at the MIT Media Lab in the Lifelong Kindergarten Research Group. Her current research focus is developing community-centered creative learning spaces to support marginalized youth and their families.

2025 STRATEGIC PRIORITIES

Equity and Accessibility: The Lifelong Kindergarten group at the MIT Media Lab develops innovative technologies and cultivates caring communities to engage young people from diverse backgrounds in creative learning experiences. The group is deeply committed to bringing about change in the world and improving the lives of young people, especially those from marginalized and vulnerable communities. Notable projects from the Lifelong Kindergarten group include The Computer Clubhouse Network, Scratch, Makey Makey, and Learning Creative Learning. The Summer Coding Workshop Series will focus on reaching a diverse group of participants and reinforcing stories from marginalized communities that are drawn from the Tacoma Public Library Summer Reading Program. In addition, the Summer Coding Workshop Series will grant Tacoma youth the opportunity to be among the first group of people to create using the new app.

The Summer Coding Workshop Series will engage a diverse group of participants in an opportunity to expand their marketable skills and increase digital access across the city. When the Summer Coding Workshop Series concludes,

the iPads will be made available to be used at all the Tacoma Public Library branches for coding, animation, reading, and other creative learning activities. Having iPads available for Tacoma Public Library use will allow more young people to participate in library activities in a non-traditional way and may encourage them to explore other resources and activities the library offers. The technology currently available at the Tacoma Public Libraries does not allow for patrons to participate in collaborative creative learning activities, such as mobile coding or drawing/animating with tools such as Procreate and Scratch.

EVALUATION AND FOLLOW UP: These contingency funds are provided to sponsor the first Summer Coding Workshop Series in Tacoma, and contingency funds are intended as a one-time funding source. Event organizers will be provided with information on how to apply for future grants and event funding opportunities at the City of Tacoma during standard application cycles.

STAFF/SPONSOR RECOMMENDATION: Sponsors recommend providing up to \$7,000 to sponsor the Summer Coding Workshop Series.
