**COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL**

**Government Performance and Finance Committee**

Council Member Lonergan stated the Committee heard the August and third quarter financial reports, noting the City continues to be in good financial condition, and revenues and expenditures are favorable through the first nine months of 2014. He then stated the October 15, 2014 meeting included an update on File Local, an online portal that will provide a one-stop, hassle-free, fully secure website for businesses to renew their City business licenses and pay Business and Occupation tax, and it will be phased-in starting in early 2015. Council Member Lonergan stated the Committee also interviewed candidates for the Board of Ethics and the Audit Advisory Board, and recommended the appointment of Rachel Mardock to the Audit Advisory Board and Kristen Smith to the Board of Ethics. He concluded by stating the Committee’s next meeting is scheduled for tomorrow, December 3, 2015, at 4:30 p.m. in conference room 248, and will include presentations on the City’s Local Improvement District program and the Microsoft Enterprise Agreement Renewal.


Council Member Boe provided information on a number of events happening in Tacoma throughout the holiday season, including Zoo Lights at Point Defiance Zoo and Aquarium, the Franciscan Polar Plaza ice skating rink at Tollefson Plaza, Our Gay Apparel by the Seattle Men’s Chorus, the film Ich Hunger with live dance by the BareFoot Collective at the Broadway Center for the Performing Arts, the Dickens Festival at Stadium, the Fort Nisqually 19th Century Christmas, an aquatic nighttime adventure at the Pier Peer in Tacoma event, Colossal Soul Holiday Show, the Sounds of the Season by the Tacoma Symphony at the Pantages Theater, the Nutcracker and the Tale of the Hard Nut by the Tacoma City Ballet, and the Christmas Revels.

Council Member Campbell stated three years ago the Tacoma School District had a graduation rate of 55 percent, and this year they graduated 78 percent of their students. He congratulated the school district on their hard work.

Council Member Ibsen provided additional information on family events in Tacoma, including a historical re-enactment at the Fort Nisqually 19th Century Christmas, and a Fair Trade Market at the Bethany Presbyterian Church.
