## Update on Sports Venue Development

Mrs. Debbie Terwilleger of Metro Parks Tacoma and Mr. Dean Burke of Tacoma South Sound Sports Commission provided an update from last month's meeting on the development of plans to provide upgrades and renovations of area sports complexes and athletic fields.

Mr. Burke stated that the survey data is still being collected and that the data is more for counting and ranking facilities rather than needs assessment and free input. The sports commission goal is to have an action plan prepared by the end of the year.

Debbie Terwilleger stated that once Metro Parks gets an accurate inventory, then that begins the strategic plan updating and goals development. Metro Parks' goal is to have this inventory process complete by summer.

Ms. Terwilleger asked what Metro Parks can do for Tacoma Schools. Kurt Miller responded that middle school and high school gymnasiums are a great opportunity for Metro Parks. Mr. Miller

stated that 30%-35% of students participate in school sports and therefore are connected to school in that way.

Tim Reid responded that Metro Parks cannot attract regional and national level field competitions because there are minimum standards such as the number of fields available for active play at the same time. Dean Burke responded that number of fields, lights and seats are the main determining factors that organizations look at when scheduling premier events.

Aaron Pointer mentioned that getting/keeping the Tacoma Dome updated and prepared for state level high school competition is important. Evette Mason mentioned lacrosse events, Nancy Davis mentioned water sports, and Kurt Miller mentioned dragon boats. Mr. Pointer also mentioned the many great golf courses in the area.

Mr. Burke mentioned that branding and exposure is important for them to move forward. The group suggested several meetings and opportunities that the Sports Commission could discuss their mission at such as city council meetings, Tacoma Schools Planning & Construction, Pierce County Cities and Towns, TV Tacoma, etc.
