## **ORDINANCE NO. 28314**

2 AN ORDINANCE related to the vacation of City right-of-way; vacating a 3 portion of the South Proctor Street right-of-way lying southerly of South 19th Street; reserving necessary easement rights; and adopting 4 the Hearing Examiner's Findings, Conclusions, and Recommendations 5 related thereto. 6 WHEREAS all steps and proceedings required by law and by resolution 7 of the City Council to vacate the portion of the right-of-way hereinafter 8 9 described have been duly taken and performed; Now, Therefore, 10 BE IT ORDAINED BY THE CITY OF TACOMA: 11 12 Section 1. 6	of the Northeast Quarter of Section 12, Township 20 North, Range 02 East, W.M., more particularly described as follows:

9	All that portion of South Proctor Street as described in			
10	Auditor's File No. 1489549, records of Pierce County Auditor, lying southerly of a line 35.00 feet South and parallel with the			
11	North line of said Section 12.			
12 13	Situate in the City of Tacoma, County of Pierce, State of Washington;			
14	is hereby vacated, and the land so vacated is hereby surrendered and			
15 16	attached to the property bordering thereon, as a part thereof, and all right			
17	or title of the City in and to the portion of the right-of-way so vacated does			
18	hereby vest in the owners of the property abutting thereon, all in the			
19 20	manner provided by law; provided, however, that there is hereby retained			
21	and reserved, pursuant to the statutes of the state of Washington, the			
22	following easement, to-wit:			
23	An easement is reserved over the vacation area to the City of			
24 25	Tacoma for use specifically by the City's Department of Public Utilities as well as for any and all City utility purposes generally.			
26	In the event that City utilities are relocated, formally abandoned and/or removed from the retained easement area and the

easement is deemed, in the City's discretion, to be no longer necessary, the City shall, upon formal request, relinquish the no longer necessary easement, or any part thereof, as retained herein.

7	easement over and along the northerly 10 feet of the subject South Proctor			
8	Street vacation area in favor of Century Link for future facilities, if requested.
